**Re: Challenge to the Eligibility and Qualifications of
Representative Vernon Jones, Candidate for Georgia State
House of Representatives District 91.**

Dear Secretary Raffensperger:

Our law firm represents Faye Coffield, a registered voter and eligible elector in Georgia State House of Representatives District 91 ("House District 91"). Ms. Coffield resides and is registered to vote at 3261 Chaparral Way, Lithonia, Georgia, 30038. Ms. Coffield submits this Complaint challenging the eligibility and qualifications of Representative Jones, who recently qualified as a candidate for reelection as Representative for House District 91, in accordance with O.C.G.A. § 21-2-5.

Under Georgia law, the burden of proof in an action challenging the eligibility of a candidate for office is placed entirely upon the candidate to establish his eligibility for office. *Haynes v. Wells*, 273 Ga. 106, 108-09 (2000). The party challenging the candidate "is not required to disprove anything" regarding the candidate's eligibility to run for office. *Id.* As further detailed below, upon information and belief, Representative Jones does not reside within House District 91 and has not been a "resident of the territory embraced within [House District 91] for at least one year preceding" this year's election. O.C.G.A. § 28-2-1(b); *see also* Ga. Const. Art. III, Sec. II, Par. III(b).

I. Factual Background

The General Election for House District 91 will be held on November 3, 2020, and the primary election for the same will be held May 19, 2020. According to the Secretary of State's public website, Representative Jones submitted a notice of

candidacy and, presumably, tendered the requisite qualifying fee on March 2, 2020.¹ That same website lists a Lithonia, Georgia, Post Office Box as a mailing address for Representative Jones. Upon information and belief, Mr. Jones is currently registered to vote at residential property within the City of Stonecrest, 5560 Mayfair Crossing Drive, Lithonia, Georgia, 30058 (the “Stonecrest Property”).²

In past filings with the Georgia Government Transparency and Campaign Finance Commission and the Federal Election Commission, Representative Jones has listed the following addresses for purposes of candidate information or notice of candidacy:

- A Decatur, Georgia, Post Office Box for candidacy for the United States Senate in 2008;
- An Atlanta, Georgia Post Office Box for candidacy for the United States Congress, District 4 in 2010;
- Another Decatur, Georgia, Post Office Box for election as Dekalb County Sheriff in 2014;
- The Stonecrest Property for the same 2014 Dekalb County Sheriff Election; and
- A Lithonia, Georgia Post Office Box for candidacy for the House District 91, beginning in 2016.

While none of these filings necessarily indicate present (or past) residency in and of themselves, they are indicative of Representative Jones’s continually changing addresses filed for official use with other branches of government. Further, the various addresses demonstrate little nexus to House District 91.

Representative Jones listed an ownership interest in property at the same address in his 2013 Personal Financial Disclosure Statement filed with the Dekalb County Voter Registration and Elections Office.³ Conversely, Representative Jones listed no ownership interest in the same property in his Personal Financial Disclosure Statements filed with the Georgia Government Transparency and Campaign Finance

Commission, covering calendar years 2015–2019.⁴ The latter is apparently accurate and confirmed by Dekalb County Property Records which show a sale transferring ownership of the Stonecrest Property from Representative Jones to another individual on or about August 31, 2001.⁵

Though he may be registered to vote at the Stonecrest Property, Lithonia, Georgia, upon information and belief, Representative Jones actually resides at 854 Moreland Avenue SE, Atlanta, Georgia, 30316, a property he purchased on or about May 31, 2019.⁶ This residence is located in the City of Atlanta and within House District 89—not House District 91. Further, upon information and belief, at least two different utility accounts (a cell phone and a landline) are associated with Representative Jones and have a service addresses of 854 Moreland Avenue. Additionally, upon information and belief, the billing address associated with that landline is for a P.O. Box located in the Buckhead neighborhood of Atlanta, the same P.O. Box provided in the 2010 Statement of Organization for Vernon Jones for Congress, filed with the Federal Elections Commission.⁷

II. Representative Jones has not continuously resided within District 91 for one year prior to the election.

Georgia law requires that every candidate qualifying for office “meet the constitutional and statutory qualifications for holding the office being sought.” O.C.G.A. § 21-1-5(a). With regard to members of the Georgia House of Representatives, the Georgia Constitution provides:

At the time of their election, the members of the House of Representatives shall be citizens of the United States, shall be at least 21 years of age, shall have been citizens of this state for at least two years, and shall have been legal residents of the territory embraced within the district from which elected for at least one year.

Ga. Const. Art. III, § II, Par. III(b). The Georgia Election Code echoes the same principle, providing that “[a] member of the House of Representatives . . . at the time of such member's election shall have been a resident of the territory embraced within such district for at least one year preceding such time.” O.C.G.A. § 28-2-1(b). The synthesis of these provisions, as explained by Deputy Attorney General Dennis Dunn in a 2001 Unofficial Opinion, is that **“a candidate for the General Assembly must meet this one-year residency requirement for the year immediately preceding the election for that office.”** Ga. Op. Atty. Gen. U2001-3, 2001 WL 1041272 (citing 1989 Ga. Op. Atty. Gen. 89-31 and 1981 Ga. Op. Atty. Gen. U81-28) (emphasis added).

In determining the residency of a candidate, the term “residence” refers to “domicile.” O.C.G.A. § 21-2-2(32). *See also Handel v. Powell*, 284 Ga. 550; *Clark v. Hammock*, 228 Ga. 157 (1971). The determination of a person's “domicile” is a factual question; however, the General Assembly has established a series of rules for determining residency, which are set forth in O.C.G.A. § 21-2-217(a). The rules contained in O.C.G.A. § 21-2-217(a) are to be followed so far as they are applicable. *Id.*; *see also Handel v. Powell*, 284 Ga. 550, 554 (2008).

Representative Jones does not satisfy the constitutional or statutory requirement that he reside within House District 91 for at least one year preceding the election. Rather, Representative Jones sold his interest in the Stonecrest Property he currently lists as his residence in 2001 and, upon information and belief, has been associated with at least five different residential addresses since that time—all outside House District 91. The law though, requires that Representative Jones's “habitation [be] fixed, without any present intention of removing therefrom,” for purposes of determining residency. O.C.G.A. § 21-2-217(a)(1). Under these circumstances, Representative Jones's habitation is not “fixed” within House District 91, and—at minimum—Representative Jones's actions indicate a “present intention of removing therefrom[.]” *Id.*


Moreover, “if a person removes to another . . . municipality in this state with the intention of making it such person's residence, such person shall be considered to have lost such person's residence in the former . . . municipality[.]” O.C.G.A. § 21-2-217(a)(4.1). Here, Representative Jones has removed from the City of Stonecrest when he left the Stonecrest Property and has now removed to the City of Atlanta—and utility accounts indicate an intention of remaining there. Accordingly, Representative Jones has lost his former residence within the City of Stonecrest as a matter of law. The City of Stonecrest of course is within House District 91, while the City of Atlanta is not. Thus, since Representative Jones has lost residence within Stonecrest, he cannot then claim that residence to pursue election to the Georgia House of Representatives to represent the residents of House District 91.

III. Conclusion

Georgia's Constitution and Election Code are clear in their requirement that residency be established and continuous within a candidate's district. Representative Jones is not qualified and eligible to be a candidate for House District 91 in the 2020 elections since he does not reside within the district and has not done so continuously for the year leading up to the election. Accordingly, we respectfully request that the Secretary of State withhold Representative Jones's name from the ballot or strike Representative Jones's name from the ballot if the ballots have now been printed. Thank you for your attention to this matter.

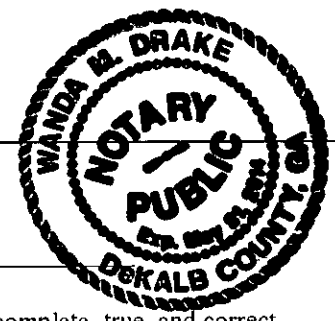


